- School systems are tax-exempt therefore the only charges invoiced will reflect the commodity and the AGL Base Charge.
- The awarded vendor will supply the total firm natural gas requirements to all current, planned and acquired locations of the Catoosa County School System located on the AGLC distribution system for the term of the contract.
- Catoosa County School System will NOT be accessed deposits to establish firm natural gas accounts with the awarded supplier.

**GENERAL CONDITIONS:**

- A. Consolidated billing must be provided.
- B. If an account needs to be changed to a different marketer as a result of Georgia PSC directive, cancellation charges shall not be assessed to the Catoosa County School System.
- C. The solicitation and any corresponding contract resulting from the proposal shall incorporate all relevant Federal, State, and Local laws.
- D. Any additional fees and their calculations MUST be provided.
- E. The Catoosa County School System reserves the right to reject any and/or all proposals.
